Competitors face obstacles a cowboy encounters on a ranch

A posse of extreme cowboy racers clearly enjoyed splashing through the water hole on a dusty obstacle course at the Horse Park at Woodside on a recent hot and sunny weekend.

Dozens of spectators came and went, curious to see what this relatively new equestrian sport from Texas is all about. Trish Clayburgh was so intrigued with the Woodside Challenge, she decided to go back to Palo Alto to trailer over her horse Maggie so they could be a late entry "just for the fun of it." They became the 36th competitor.

Most of the riders were California cowgirls who drove hours to compete on Saturday, Aug. 23. The Extreme Cowboy Association sanctioned event started over an hour late in the morning and was supposed to end that evening.

When daylight ran out, the competitors who were still waiting their turn were invited to leave their horses there for free, and then finish up their rides the following morning.

In the last division on Sun-

day, the pros rode a course that included standing on top of their saddles to ring a bell mounted on a fake storefront, roping a horse-sized wooden duck, stopping to unsaddle and then riding bareback over jumps, doing a spin and backing up over a small hill.

Competitors were judged on how they approached and handled each obstacle, based on horsemanship and speed. Mike Raynor of Redwood City won the Pro division, as well as the Intermediate and Non-pro divisions, earning him enough points to qualify him to go on to the regional championships in Southern California and the world championships in Texas, both in October.

He has been competing on his quarter horse Flash Gordo in Extreme Cowboy Association events for a couple of years now, and said: "I've been doing very, very well. I have a great horse. I have to polish my riding, but he's potentially a world champion."

Raynor organized, worked at and rode in the Woodside Challenge. He said a combination of

factors slowed down the event. This is the first time the Horse Park has hosted the event and it attracted a lot of new competitors who needed extra time to walk through, study, and then ride through the courses.

"You don't know the course

until a half hour before," he said, and the course changes twice in each of the eight divisions.

The obstacles were ones a cowboy might encounter in a ranch situation such as riding over logs, bridges, closing a gate, carrying a bucket of water on

horseback, dismounting on the wrong side of a horse to check a hoof and moving cattle.

Some manmade obstacles spooked some horses and added time to the runs. Competitors

sometimes had to carry a flag on a pole, pass under fluttering shimmery streamers, and ride through a bunch of foam noodles that are used in swimming pools.

Riders have 30 seconds to make it through each obstacle. A whistle is blown to indicate when that time is up, or in the case of working with cattle, when the task has been completed.

Raynor's best time at the event was 3:20. By contrast, a first-time competitor finished an intermediate course in just under nine minutes.

Raynor's daughter, Merilee, a junior at Woodside High, raced for the first time and won the Youth division.

Nevan Elam came with his wife and daughter to watch the Raynors ride because they know each other from Woodside School days and wanted to be supportive.

Raynor belongs to the San Mateo County Horseman's

Association and a number of fellow members came to watch and/or ride, eager to see what he has been training for and how it compares to time trials and other competitions. Mike Tyo of Redwood City rode his mare mule in the Intermediate division.

Sue Landaiche, a horse trainer in Los Gatos, won the Green Horse division on her 6-year-old palomino, Paris. “We sort and pen cattle, we like going out on the trails, like the beach, go English and Western,” she said. Extreme cowboy racing “is something I’ve had my eye on for years. It’s nice to have one local (event) in such an open space” rather than indoors.

She paid a \$50 entry fee and said, “That’s a really good value for a nice full day of fun” at an event “that’s truly judged on your horse’s versatility, willingness, and horsemanship. It’s an opportunity to express yourself.”

Coral Armstrong trailered in her quarter horse from Soledad to try out the sport after having competed in versatility ranch

horse events before. “I like a more challenging course,” she said. “My horse does really better at speed.” She went on to win second place and a buckle in the non-pro division.

Other winners include: Emily Fisk of Fillmore, California, in the Novice division; Cassie Brown of Burlingame in the Young Guns division; and Rick Polniaszek of Half Moon Bay in the Ride Smart division.

One woman went home angry when time ran out on Saturday and she didn’t want to return Sunday. Raynor gave her a refund. Other than that, he said, he received very positive feedback about having the event in Woodside again next year.

He’s hopeful that things will get off to a better start next time.

One experienced Extreme Cowboy Association competitor trailered in two horses from Yosemite and one of the horses collapsed and died in the trailer about a mile from the Horse Park. Other than that traumatic incident, Raynor said, he was pleased to see the weekend go injury-free. ▣

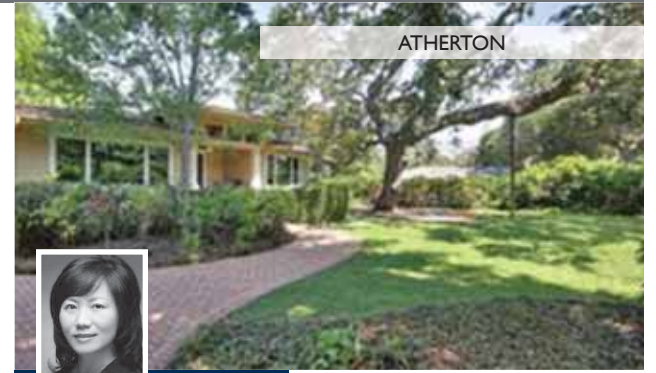

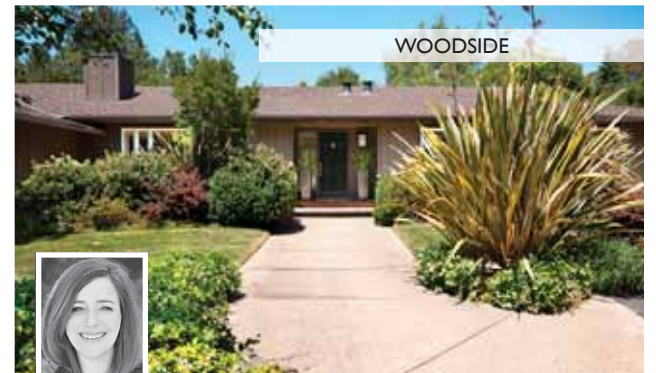

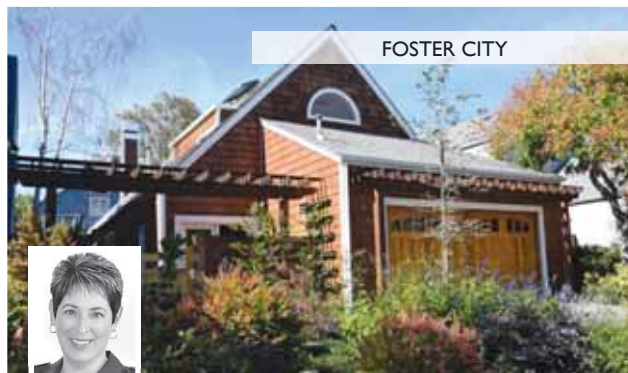
